- New Law On Education (2017)
Art. 37-39 introduce National System of Qualifications, National Qualifications Agency
- Government resolutions 2018-2019. NQA statute approved. NQA composition approved
- Chairman and deputy Chairs elected and appointed

- “The National Qualifications Agency is a permanent collegial body authorized to implement public policy in the area of qualifications” (Art. 38, para. 1)
- 12 member : 3 – employers, 3 – trade unions, 6 – governmental representatives (Ministry of Education and Science, Ministry of Economics, Ministry of Social Policy)
- 7 NQA members work at a regular basis
- 62 (max) officers in Secretariat

NQA main tasks. Policy

- participates in the development of laws and regulations in the area of qualifications
- coordinates efficiency assessment of state policy in the area of qualifications
- provides for forecasting needs of the labour market in qualifications
- interacts with bodies and establishments of quality assurance in education

NQA main tasks. NQF

- provides support to the introduction of the National Qualifications Framework with requirements of this Law
- performs international cooperation in the area of qualifications, including with the goal of harmonizing the National Qualifications Framework with similar international documents
- provides information support to the introduction of the National Qualifications System and the National Qualifications Framework
- creates and maintains the Qualification Registry

- develops a draft procedure of development, enforcement and review of professional standards and submits it to the Cabinet of Ministers of Ukraine for approval
- registers professional standards and ensures open access to standards
- coordinates development of professional standards
- performs accreditation of qualification centres

- develops recognition criteria and procedures for qualification obtained in other countries
- forms requirements to qualifications awarding procedures, recognition of outcomes of non-formal and informal education
- interacts with bodies and establishments of quality assurance in education

- Economical Approach to quality evaluation
- Accountability of universities (HEIs) as budgetary organizations
